1 Title of Rule

This Rule is the *National Electricity Amendment (Minor changes) Rule 2019 No. 9*.

2 Commencement

This Rule commences operation on 21 November 2019.

3 Amendment to the National Electricity Rules

The National Electricity Rules are amended as set out in Schedule 1.

In clause 3.18.2(b)(2), insert space between "paragraph" and "(g)".

In clause 4.8.5B, renumber paragraphs (1) and (2) to be (a) and (b), respectively.

[12] Clause 4.8.5B Notifications of last time of AEMO intervention

In clause 4.8.5B(a), renumber (i) and (ii) to be (1) and (2), respectively.

[13] Clause 4A.G.19 Volume limits

In clause 4A.G.19(d)(2), italicise "region".

[14] Clause 4A.G.22 MLO products

In clause 4A.G.22(a)(1)(i), omit "clause".

[15] Part D in Chapter 5 Network Planning and Expansion

In chapter 5, under Part D, above rule 5.10, omit the note.

[16] Clause 5A.C.3 Negotiation framework

In clause 5A.C.3(a)(3), after "including", omit ";" and substitute ":".

[17] Clause 5A.D.1 Publication of information

In clause 5A.D.1(a)(7), omit "clause 5.3A.3(b)(1)(vii), (2)-(7)" and substitute "clauses 5.3A.3(b)(1)(vii) and 5.3A.3(b)(2)-(7)".

[18] Clause 5A.D.1A Register of completed embedded generation projects

In clause 5A.D.1A(e), omit "clause 5.4.5" and substitute "rule 5.18B".

[19] Clause 5A.D.3 Application process

In clause 5A.D.3(f), omit "receipt of the information," and substitute "receipt of the information".

[20] Clause 5A.D.3 Application process

In clause 5A.D.3(f)(2), after the word "if", omit ";" and substitute ":".

[24] Clause 5A.G.3 Termination of proceedings

In clause 5A.G.3(b), under Note, omit "See" and substitute "see".

[25] Clause 6A.7.3 Cost pass through

After subparagraph 6A.7.3(a1)(6), insert the following note:

This paragraph (6) does not apply in Victoria (see clause 5.20B.4(a)).

[26] Clause 6A.14.1 Contents of decisions

After clause 6A.14.1(5C), renumber paragraphs (5E) and (5F) to be (5D) and (5E), respectively.

[27] Clause S6A.2.2A Reduction for inefficient past capital expenditure

In clause S6A.2.2A(a), omit "clause 6A.14.1(5E)" and substitute "clause 6A.14.1(5D)".

[28] Clause 7.8.2 Metering installation components

In clause 7.8.2(a), omit "(other than a type 7 *metering installation*) :" and substitute "(other than a type 7 *metering installation*):".

[29] Chapter 10 Glossary

In paragraph (e) of the definition "*plant*", omit "any of any of" and substitute "any of".

[30] Chapter 10 Glossary

In the definition of "*real estate developer*", insert a full stop at the end of the sentence.

[31] Chapter 10 Glossary

In paragraph (b) of the definition "*response breakpoint*", omit "in relation" and substitute "In relation".

In the definition of "**new Chapter 7**", under clause 11.86.1, italicise the word "Rules".

[36] Clause 11.116.4 Reliability Forecast Guidelines

In clause 11.116.4, renumber paragraph "(g)" to be "(f)".
