- (h) the Australian Energy Market Act 2004 of the Commonwealth.

1 Title of Rule

2 Commencement

This Rule commences operation on [3 March 2022].

3 Savings and Transitional Amendment to the National Electricity Rules

The National Electricity Rules are amended as set out in Schedule 1.

Schedule 1 Savings and Transitional Amendment to the National Electricity Rules

(Clause 3)

[1] New Part ZZZZ[x] Extension of time and reduction in scope of the 2022 reliability standard and settings review

In Chapter 11, after Part ZZZZ[x], insert a new Part:

Part ZZZZ[x] Extension of time and reduction in scope of the 2022 reliability standard and settings review

11.[xxx] Rules consequential on the making of the National Electricity Amendment (Extension of time and reduction in scope of the 2022 reliability standard and settings review) Rule 2022

11.[xxx].1 Definitions

(a) In this rule 11.[xxx]:

commencement date means the date of commencement of the *National Electricity Amendment (Extension of time and reduction in scope of the 2022 reliability standard and settings review) Rule 2022*.

current RSSR means the *reliability standard and settings review* that is due to be completed by the *Reliability Panel* in 2022 under clause 3.9.3A.

(b) Italicised terms used in this rule 11.[xxx] have the same meaning as in Chapter 10 as in force on and from the commencement date.

11.[xxx].2 Expiry date

This rule 11.[xxx] expires on 28 October 2022.

11.[xxx].3 Application of clause 3.9.3A

For the purpose of the current RSSR, clause 3.9.3A applies as modified by this rule 11.[xxx].

11.[xxx].4 Modification to clause 3.9.3A

(a) From the commencement date, clause 3.9.3A(d) is deleted and replaced with the following:

"(d) " By 30 August 2022, the *Reliability Panel* must:

- (1) conduct the *reliability standard and settings review* in accordance with the *Rules consultation procedures* and this clause; and
- (2) publish a report in accordance with clause 3.9.3B on the *reliability standard* and *reliability settings* that it recommends should apply for the period 1 July 2025 to 30 June 2028."
