Accelerating smart meter deployment rule change

I am writing to express my views on the draft determination and rule for accelerating smart meter deployment.

1) I am opposed to the installation of smart electricity meters that emit radiofrequency (RF) radiation. We know that RF radiation is harmful, due to, working with a Radiographer, and developing, the Xray's, the rules were stringently applied, avoiding, at all times, unnecessary exposure to anyone.

2) I do not consent to the installation of smart electricity meters that emit radiofrequency (RF) radiation on, or inside my home.

This is because RF radiation is constantly being emitted into the home, including all the occupants that are in the home, 24 hours a day, and seven days a week constantly.

3) Another reason why I object to the roll-out of wireless smart meters is that they emit radiofrequency radiation. It has been scientifically shown that this radiation is harmful to people and all Lifeforms, including the environment.

For example

Customers must be informed that wireless smart meters emit RF Radiation that is a class 2B Carcinogen.

The Legislation must explicitly acknowledge that.

RF Radiation has been classified as a 2B Carcinogen by The IARC:

4) I am also opposed to the Roll-out of radiation- emitting smart meters, is because of the, negative effects they do to all people, and especially to people with electromagnetic hypersensitivity. For example some people are more sensitive/vulnerable to RF Radiation

than other's including Foetuses, babies, the sick people with Cancer, the elderly, and the immune compromised.

I Do Not Consent to any electricity company collecting data about my electricity usage and sharing it with 3rd parties without my written consent, due to this example.

Not all people want their privacy/sensitive Information exposed with data sharing to any 3rd party, that is Not Acceptable if people's Privacy is on display corruption and crime's are committed and this is Not Acceptable.

Customers must be given details, about exactly what Data Sharing their electricity provider plans, and the opportunity to give or with hold their approval.

5) The Legislation must require this body, to Provide appropriate Compensation for this outcome.

6) The Legislation must require all electricity provider's, and smart meter manufacturers, to have adequate Insurance covering them specifically for adverse effects, related to the Meter's and/or the Radiofrequency Radiation they emit.

Questions that needs to be answered by the AEMC

What is the total cost of replacement of electricity Meter's, as proposed for New South Wales, Queensland, Australian Capital Territory, and South Australia?

Can the expence be justified given the aforementioned Negative Outcomes?

Can the consumer be forced to accept a Radio Frequency- Radiation emitting smart Meter, or have their Data Shared with 3rd parties, if they Do Not Give their Consent?

Most smart meters emit radiofrequency (Wireless Radiation)

Yet, there will, still be an option for using Type 4A Non Communicating Meters.

,*All customers must be informed, and able to choose Non Radiating Electricity Meter's, Meter's that Do Not Emit Radiation Frequency and Not be financially-or in any other way penalised for the choice.

The Legislation must be changed to require electricity companies to roll out non-radiation-emmitting smart meters.

The Number of notices that retailers send to customers before a new meter deployment should not be reduced from two to one.

The minimum number of business days required for notices should also not be reduced from what is currently required.

The Legislation also needs to include that all Customer's have the Rights to be consulted thoroughly prior to any, Meter Changes take place, also importantly, all Customers must have ample time to give either their written consent, or their written decline for any Meter changes.
