Proposed National Electricity Amendment (Minor Changes) Rule 2009

1. Title of Rule

This Rule is the *Proposed National Electricity Amendment (Minor Changes) Rule 2009*.

2. Commencement

This Rule commences operation on 31 March 2009.

3. Amendment of the National Electricity Rules

The National Electricity Rules are amended as set out in Schedule 1.

4. Amendment of the National Electricity Rules

The National Electricity Rules are amended as set out in Schedule 2.

Schedule 1 Amendment of National Electricity Rules to correct formatting and numbering anomalies

(Clause 3)

[1] Chapter 6, Part B Classification of Distribution Services and Distribution Determinations

In Part B of Chapter 6, omit the headings “Division 1 Classification of distribution services”, “Division 2 Distribution Determinations” and “Division 3 Guidelines”.

[2] Chapter 11, Appendix 1, Part B Classification of Distribution Services and Distribution Determinations

In Part B of Appendix 1 of Chapter 11, omit the headings “Division 1 Classification of distribution services”, “Division 2 Distribution Determinations” and “Division 3 Guidelines”.

[3] Chapter 6, Part L Dispute Resolution

In Chapter 6, immediately after the heading “Part L Dispute Resolution”, insert the rule number and heading “6.22 Dispute Resolution”.

[4] Chapter 11, Appendix 1, Part L Dispute resolution

In Appendix 1 of Chapter 11, immediately after the heading “Part L Dispute resolution”, insert the rule number and heading “6.22 Dispute Resolution”.

[5] Chapter 7 Metering

In Chapter 7, immediately before the heading “7.1 Introduction to the Metering Chapter”, insert the chapter number and heading “7. Metering”.

[6] Chapter 8 Administrative Functions

In Chapter 8, immediately after the chapter heading “8. Administrative Functions”, insert the rule number and heading “8.1 Administrative functions”.

[7] Chapter 8A Participant Derogations

In Chapter 8A, immediately after the chapter heading “8A Participant Derogations”, omit the heading “Purpose of this Chapter” and substitute “Note”.

[8] Chapter 11, Part M, Division 1 General provisions

In Part M of Chapter 11, immediately after the heading “Division 1 General Provisions”, insert the rule number and heading “11.14 General provisions”.

[9] Chapter 11, Part M, Division 4 Transitional provisions of specific application to Victoria

In Part M of Chapter 11, immediately after the heading “Division 4 Transitional provisions of specific application to Victoria”, insert the rule number and heading “11.17 Transitional provisions of specific application to Victoria”.

[10] Chapter 11, Part R Regulatory Test Thresholds and Information Disclosure on Network Replacements

In the heading for Part R of Chapter 11, omit “Part R” and substitute “Part Q”.

[11] Chapter 11, Part S Performance Standard Compliance of Generators

In the heading for Part S of Chapter 11, omit “Part S” and substitute “Part R”.

[12] Chapter 11, Part T Compensation Arrangements under Administered Pricing

In the heading for Part T of Chapter 11, omit “Part T” and substitute “Part S”.

[13] Schedule 5.3 Conditions for Connection of Customers

In Schedule 5.3, immediately after the schedule heading “Schedule 5.3 Conditions for Connection of Customers” insert the clause number and title “S5.3.1a Introduction to the schedule”.

[14] Schedule 5.3a Conditions for connection of Market Network Services

In Schedule 5.3a, immediately after the schedule heading “Schedule 5.3a Conditions for connection of Market Network Services” insert the clause number and title “S5.3a.1a Introduction to the schedule”.

[15] Clause S5.5.1 of Schedule 5.5 Technical Details to Support Application for Connection and Connection Agreement

In Clause S5.5.1, insert the clause heading “Introduction to the schedule”.

[16] Clause S5.5.2 of Schedule 5.5 Technical Details to Support Application for Connection and Connection Agreement

In Clause S5.5.2, insert the clause heading “Categories of data”.

[17] Clause S5.5.3 of Schedule 5.5 Technical Details to Support Application for Connection and Connection Agreement

In Clause S5.5.3, insert the clause heading “Review, change and supply of data”.

[18] Clause S5.5.4 of Schedule 5.5 Technical Details to Support Application for Connection and Connection Agreement

In Clause S5.5.4, insert the clause heading “Data requirements”.

[20] Clause S5.5.5 of Schedule 5.5 Technical Details to Support Application for Connection and Connection Agreement

In Clause S5.5.5, insert the clause heading “Asynchronous generating unit data”.

[21] Clause S5.5.6 of Schedule 5.5 Technical Details to Support Application for Connection and Connection Agreement

In Clause S5.5.6, insert the clause heading “Generating units equal to or smaller than 30MW data”.

[22] Clause S5.5.7 of Schedule 5.5 Technical Details to Support Application for Connection and Connection Agreement

In Clause S5.5.7, insert the clause heading “Generating System Design Data Sheet, Generating System Setting Data Sheet and Generating System Model Guidelines”.

[23] Clause S5.5.2 of Schedule 5.5 Technical Details to Support Application for Connection and Connection Agreement

In Clause S5.5.2, omit “This data is required for submission” where first occurring and substitute “Preliminary system planning data is required for submission”.

[24] Clause S5.5.2 of Schedule 5.5 Technical Details to Support Application for Connection and Connection Agreement

In Clause S5.5.2, omit “This is the class of data” where first occurring and substitute “Registered system planning data is the class of data”.

Schedule 2 Amendment of National Electricity Rules to remove derogations that have expired

**[1] Part 3 of Chapter 8A – Derogations Granted to Woolnorth Studland
Bay Wind Farm Pty Ltd**

Omit Part 3 of Chapter 8A in its entirety and substitute “[Part 3 Deleted]”.

[2] Part 4 of Chapter 8A – Derogations Granted to NEMMCO

Omit Part 4 of Chapter 8A in its entirety and substitute “[Part 4 Deleted]”.

[3] Part 8 of Chapter 8A – Network Constraint Formulation

Omit Part 8 of Chapter 8A in its entirety and substitute “[Part 8 Deleted]”.

**[4] Part 9 of Chapter 8A – Participant Derogation Granted to Hydro
Tasmania**

Omit Part 9 of Chapter 8A in its entirety and substitute “[Part 9 Deleted]”.

[5] Part 10 of Chapter 8A – Statement of Opportunities

In the heading for Part 10 of Chapter 8A, omit “Statement of Opportunities”.

[6] Part 12 of Chapter 8A – Ancillary Services Provisions

Omit clause 8A.12.2 in Part 12 of Chapter 8A and substitute “[Deleted]”.
