- (c) the Electricity - National Scheme (Queensland) Act 1997 of Queensland;
- (d) the Electricity - National Scheme (Tasmania) Act 1999 of Tasmania;
- (e) the National Electricity (New South Wales) Act 1997 of New South Wales;
- (f) the National Electricity (Victoria) Act 2005 of Victoria; and
- (g) the Australian Energy Market Act 2004 of the Commonwealth.

Draft National Electricity Amendment (Inclusion of Embedded Generation Research into Demand Management Incentive Scheme) Rule 2011

1 Title of Rule

This Rule is the *Draft National Electricity Amendment (Inclusion of Embedded Generation Research into Demand Management Incentive Scheme) Rule 2011*.

2 Commencement

3 Amendment of the National Electricity Rules

The National Electricity Rules are amended as set out in Schedule 1.

Schedule 1 Amendment to the National Electricity Rules

(Clause 3)

[1] References to "demand management incentive scheme" in various clauses

In clauses 6.3.2(a)(3), 6.4.3(a)(5), 6.4.3(b)(5), 6.6.3(b), 6.6.3(b)(4), 6.8.1(b)(4), 6.12.1(9) and S6.1.3(5), omit "*demand management incentive scheme*" wherever occurring and substitute "demand management and embedded generation connection incentive scheme".

[2] New clause 6.1.1A Definitions

After clause 6.1.1, insert:

6.1.1A Definitions

In this Chapter:

demand management incentive and embedded generation connection scheme An incentive scheme for certain *Distribution Network Service Providers* developed and *published* by the *AER* under clause 6.6.3.

[3] Clause 6.6.3 Demand management incentive scheme

Omit the clause heading and substitute "Demand management and embedded generation connection incentive scheme".

[4] Clause 6.6.3 Demand management incentive scheme

Omit clause 6.6.3(a) and substitute:

- (a) The *AER*, may in accordance with the *distribution consultation procedures*, develop and *publish* a demand management and embedded generation connection scheme or schemes to provide incentives for *Distribution Network Services Providers* to implement efficient non-*network* alternatives, or to manage the expected demand for *standard control services* in some other way, or to efficiently connect *Embedded Generators*.

[5] Clause 6.6.3 Demand management incentive scheme

In clause 6.6.3(b)(4), omit "and" where lastly occurring.

[6] Clause 6.6.3 Demand management incentive scheme

In clause 6.6.3(b)(5), omit "." and substitute:

; and

- (6) the effect of classification of *distribution services*, as determined in accordance with clause 6.2.1, on a *Distribution Network Service Provider's* incentive to adopt or implement efficient *Embedded Generator connections*.
