

# Transmission Connection and Planning Arrangements

## Extension of time for draft rule determination

The AEMC has extended the standard timeframe for publishing a draft rule determination on this rule change request. The extended timeframe will enable the AEMC to hold a series of workshops on aspects of the rule change request and publish a directions paper for stakeholder comment.

### Background

The Transmission Connection and Planning Arrangements rule change request was submitted by the COAG Energy Council in July 2015. It seeks to amend aspects of the NER to improve the transparency, contestability and clarity of transmission connections, and promote a national approach to transmission planning. It largely reflects the recommendations made by the AEMC in its Transmission Frameworks Review (TFR).

### **Rationale for extension**

On 3 March 2016 the AEMC extended the period of time for publishing a draft rule determination on the rule change request. The AEMC determined that an extension was necessary for the following reasons:

- 1. **Significant and complex changes.** The rule change request proposes significant changes to the rules that underpin transmission connection and planning arrangements in the NEM. These changes, particularly those relating to connections, were commented on extensively by stakeholders in submissions to the consultation paper.
- 2. **Expanded scope.** The scope of the rule change request has expanded from that originally contemplated in the TFR. For example, the TFR set out the Commission's recommended changes to the arrangements for connecting generation assets to the transmission network. The rule change request expands the scope of these proposed changes to cover all assets connecting to the transmission network, ie load, generation and distribution networks. A diagram of the scope of the rule change request is attached to this information sheet.
- 3. **Extensive legal drafting.** Sufficient time will be required to draft the potentially significant amendments to Chapters 2, 4, 5, 6A, 8 and 10 of the NER.

As well as working through the issues above, the AEMC plans to use the extended timeframe to hold a series of workshops and publish a directions paper for stakeholder comment. Further information is provided below.

The directions paper will also set out how the Commission's policy position might apply in declared network jurisdictions (ie Victoria).


